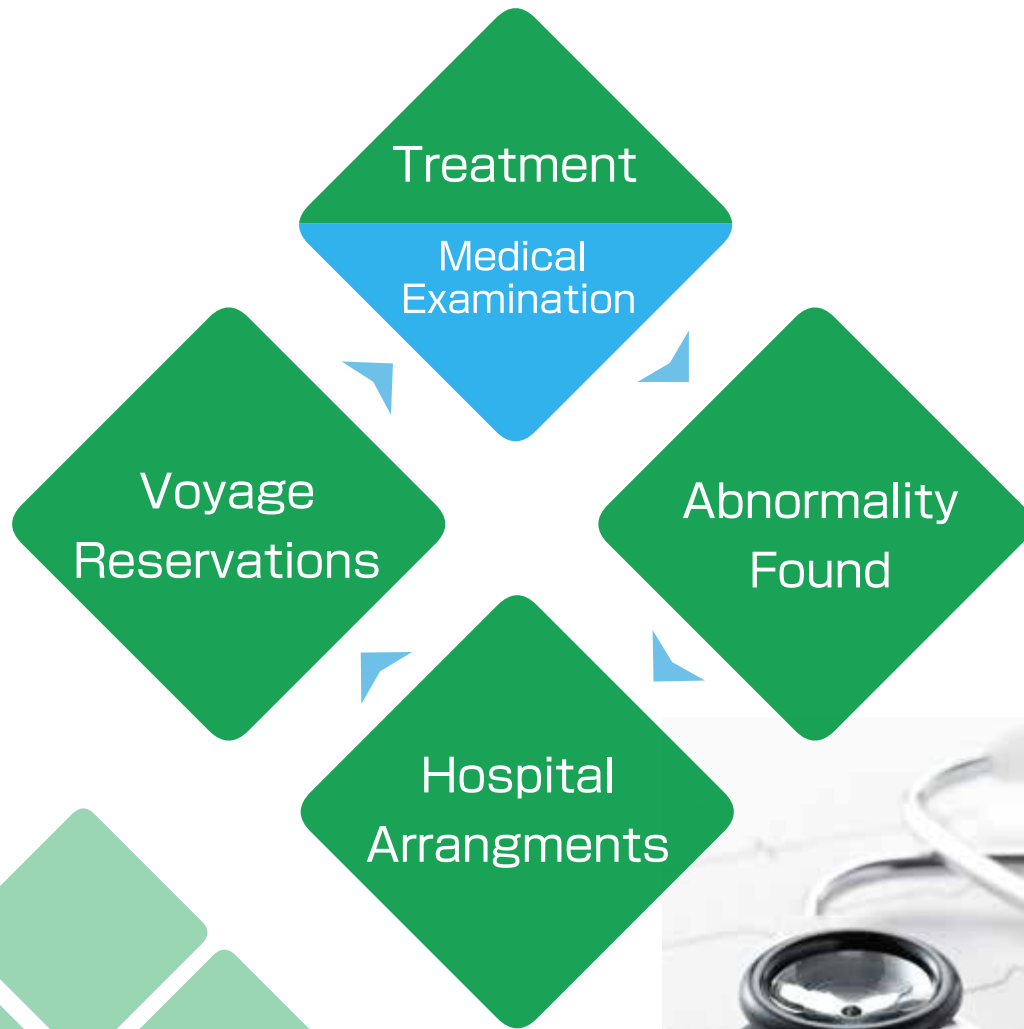

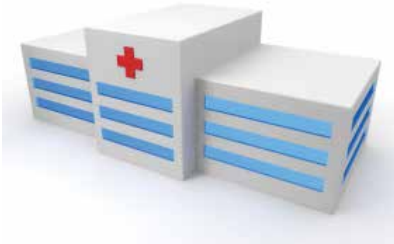

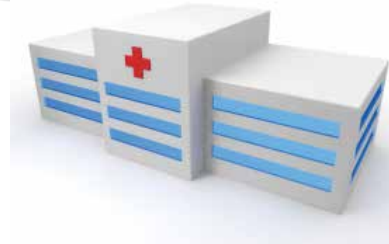
Diagram for examination for negotiations for acceptance into hospital for treatment.

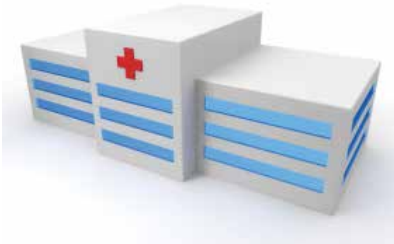

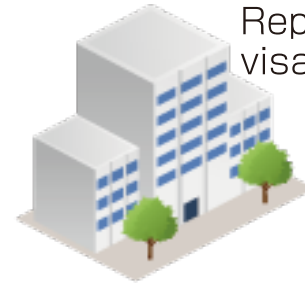

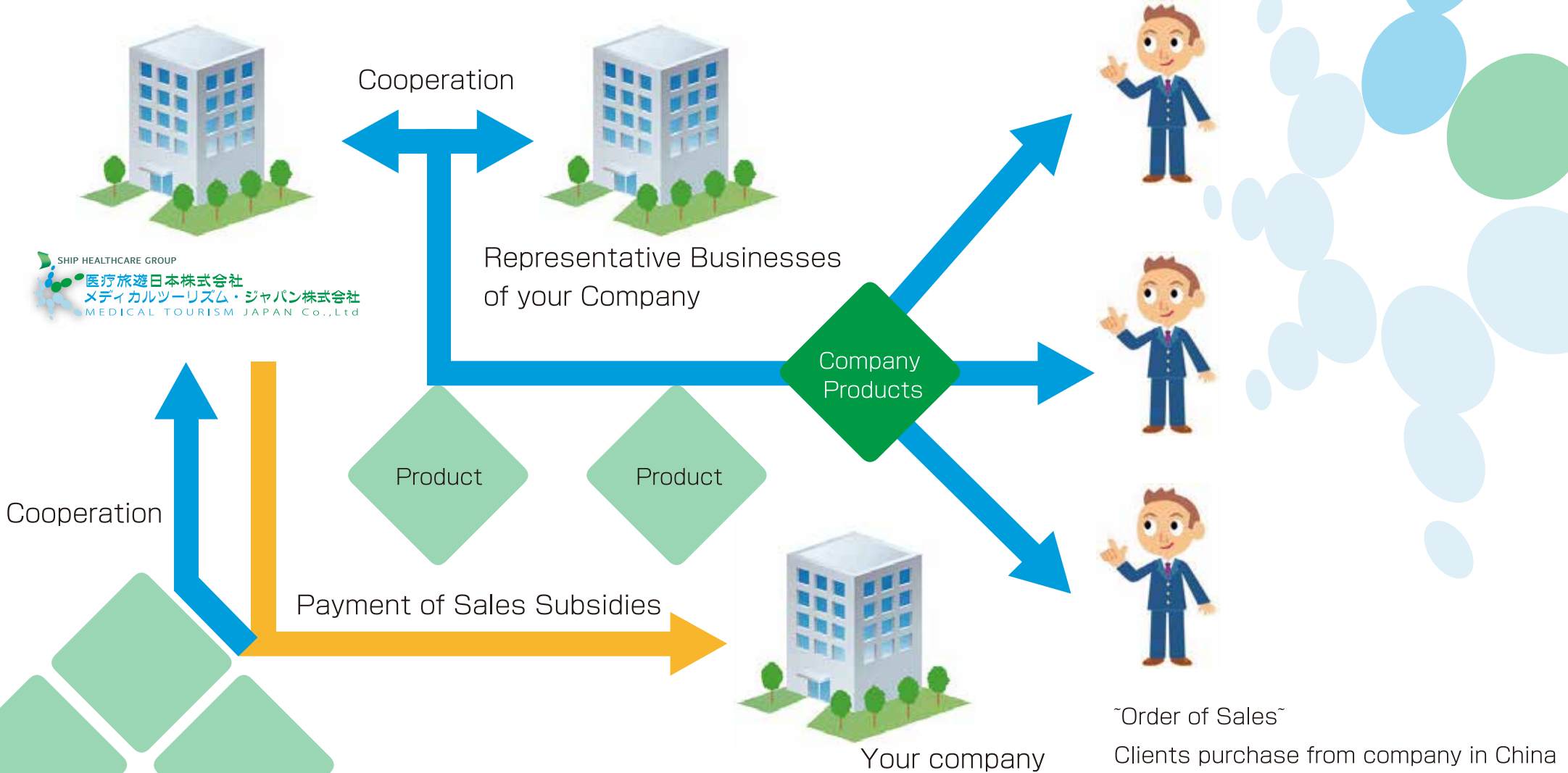

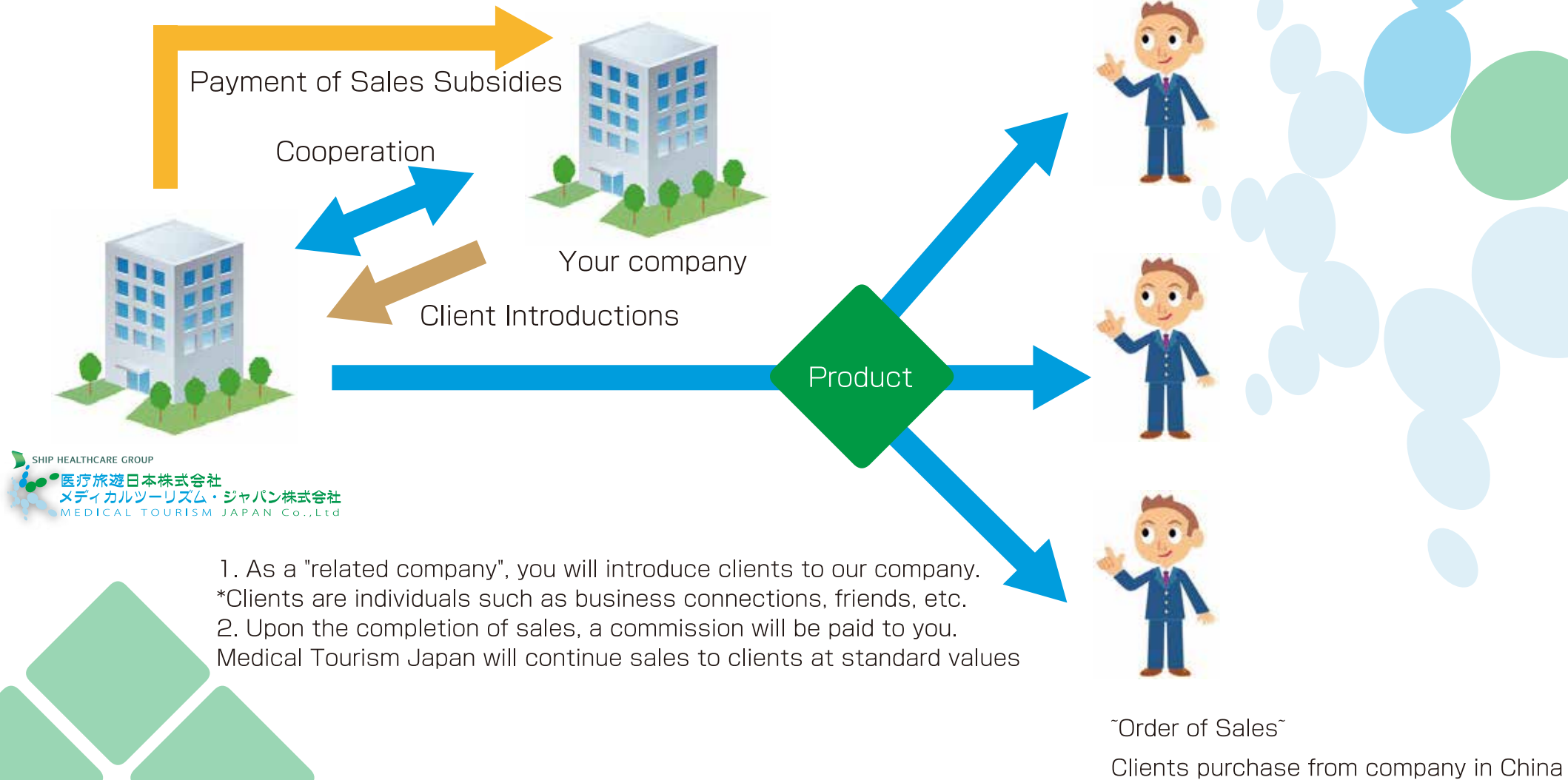
